

DECLARATION ON PERSONAL DATA PROTECTION

The new Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 known as the General Data Protection Regulation, abbreviated as **GDPR**, became effective on 25 May 2018.

Please allow us to use this way to inform you in accordance with applicable legal regulations about the fact how our company "VEZEKO s.r.o.", Jihlavská 229, 594 01 Velké Meziříčí, Company Reg. No.: 26273349, Tax Id. No.: CZ26273349, registered in the Commercial Register administered by the Regional Court in Brno, Section C, File no. 41298, will collect, process, use and protect your personal data which you announce to us, and about other facts concerning the area in question.

We have always paid appropriate attention to personal data protection. In accordance with applicable legal regulations we protect your personal data in the maximum possible extent.

If you are our customers, we only process your personal data which are necessary for you to be able to buy any of our products from us, or any spare parts or services. This means that the matter concerns the data necessary for creation of an order, and then for creation of all the documents necessary for the purchase of possible insurance of the trailer or courier services. If we are to specify your processed personal data, the matter namely concerns especially your first name, surname, address, administrative identification number, tax identification number, telephone number and e-mail address. We obtain these data directly from you and we store them for 10 years, especially for the reasons of subsequent servicing and maintenance, additional orders of spare parts or possible claims.

If you are our employees, we process only those of your personal data that are necessary for us to recruit you in the employment, to conduct your payroll agenda or to prepare your annual rendering of tax accounts for you. This means that these data include mainly your first name, surname, address, e-mail, telephone number, date of birth, bank account number and other necessary data. We obtain these data especially from you or from other public institutions, such as the Czech Social Security Administration. We then store your personal data only for the term which is prescribed by legal regulations.

If you are our supplier or another business partner, we process only those of your personal data that are necessary for fulfilment of your mutual contractual terms and conditions. This means that the matter concerns mainly the commercial name, first name, surname, address, administrative identification number, tax identification number, e-mail address and telephone number. We obtain these data directly from you and we store them for the term of 10 years.

We do not pass your personal data to any third countries or multinational companies. We only pass the personal data provided by you for processing to third parties in necessary cases, such as information system administration or tax advisory services. For this purpose we choose reliable partners only. They are bound, on the basis of a contractual relation, by the obligation of confidentiality and they must not use the personal data provided by us for

any purposes other than those for which we have made them accessible. Under certain, exactly defined conditions we are then obliged to pass some of your personal data, on the basis of applicable legal regulations, e.g. to the Police of the Czech Republic or to other law enforcement authorities or to state administration bodies in the necessary extent and within the limits of the laws.

At our company we observe corresponding technical and organisational measures in order to ensure appropriate level of security.

At the end we would still like to inform you that in connection with protection of personal data you have especially the following rights:

- Right to information
- Right to access to personal data
- Right to correction
- Right to erasure and right to be forgotten
- Right to limitation of processing
- Right to raise an objection
- Right to data portability
- Right not to be subject to solely automated processing
